## **Incentive Option Issue to Key Personnel**

The Board of Kilgore has resolved to issue 60,000,000 listed KOGOA incentive options to new key personnel following the recent Board and management changes.

The Company will issue 30,000,000 incentive options to key management personnel and 30,000,000 incentive options to a Director, Mr Brian Ayers. The incentive options to be issued to Mr Ayers will be subject to shareholder approval. All incentive options will have the same terms and conditions as the existing KOGOA class of listed options which are exercisable at 0.5 cents each and expire on 17 August 2015. These incentive options will contain vesting conditions based on service provided to the Company by each allottee.

The Company will convene a general meeting shortly to seek shareholder approval to approve the issue of the incentive options to Mr Brian Ayers and ratify the incentive option issue to key management personnel.
