ACQUISITION PERFORMANCE SHARES MILESTONE ACHIEVED

The Board of Tamaska Oil and Gas Limited (ASX: TMK or the Company) advises that the 45,000,000 performance shares forming part consideration for the acquisition of a 20% interest in the Napoleon Prospect (Talisman Deeps Project) have been converted to ordinary shares on a one-for-one basis due to achievement of the milestone.

The milestone achieved was:

*“..an independent estimate is prepared in accordance with the reporting requirements of ASX Listing Rule 5.42 by a qualified petroleum reserves and resources evaluator and assesses the **2U (P50) prospective recoverable resource of Napoleon to be greater than 120 million boe** (such resource to be reported in accordance with the ASX Listing Rules and the 2018 Petroleum Resources Management System published by the Society of Petroleum Engineers (SPE-PRMS)). For these purposes boe (barrels of oil equivalent) equates to oil plus gas converted at a ratio of 6mcf = one barrel.”*

An independent estimate of the Napoleon prospective resource was prepared by ERCE and announced by TMK on 4 October 2021. Based upon the ERCE report, the total 2U (P50) prospective recoverable resource of Napoleon is 154.6 million boe which satisfies the milestone.

The Company's capital structure is now 985,000,000 ordinary shares with no other securities on issue.
